- I have a pet peeve about individuals who are smart-alecky and disrespectful. Clint, however, was never like that towards me. I never saw him act out, even with other children. I never sent Clint to the principle's office for anything.
- 4. Our school was small, and Clint had a reputation for being disruptive.
  I recall he had brought an unloaded gun to school when he was younger. I thought he was just a kid wanting attention. I assumed he was troubled and had a difficult home situation.
- 5. I felt that Clint did well with me because he just needed someone to talk to him, treat him like a human being, and give him guidance. It wasn't that I let him run over me, he did not even try to. He was troubled, but he had a lot of potential.

  because he was manipulative. He was always strange and used speed, or
  methampetamine, with needles.

## DECLARATION OF AMBER LYNCH HARRISON

I, Amber Harrison, declare as follows:

- I met Clinton Lee Young in the Spring of 2001, when I was 15 years
   Clint was about 17 years old. Clint was my first real boyfriend.
- I met Clint through my step sister, Debbie. Debbie was dating Clint's half brother, Dano. At the time, Debbie and I lived at our father Bart's motel at Shady Shores in East Texas.
- When I first met Clint, he was very clean and well groomed. He was also very nice and outgoing, considerate and respectful. Everyone liked being around Clint.
- Clint had recently been released from the Texas Youth Commission.
   He was living with his mother and taking classes at a community college.
- 5. At the motel, Debbie and Dano shared a room, and I had my own room that I shared with Clint. Later my dad made us all move into the office. Debbie and Dano stayed in the bedroom and Clint and I stayed in the living room with Debbie's two kids.
- Everyone at the motel was using drugs, including my father, my
   Uncle Doyle, and my sister Debbie. I did not use drugs, and at first, neither did
   Clint.

- 7. Clint and I took care of Debbie's children as Debbie was often strung out on drugs. Debbie's kids were Darmi, who was 3 years old, and Michael, who was going on 5 or 6 years old. Clint and I didn't just babysit the kids, we fully took care of them including feeding them, getting them ready for school, bathing them, and putting them to bed.
- Clint and I hung out constantly. The two of us went everywhere together except when Clint thought a situation might not be safe for me. He was very protective of me.
- 9. Everything seemed fine with Clint until he started using drugs. I remember going out one night with a friend. When I returned the next day, I saw needle marks on Clint's arms and I suspected he had used drugs with Dano and Debbie.
- 10. I was very upset at Clint, and told him I thought he was better than that. I stayed with Clint, and Clint kept his drug use hidden from me, although I suspected he was still using drugs.
- 11. My relationship with Clint went downhill during his drug use. When I first met Clint, he wanted everything to be clean. But after he started using drugs, it appeared he stopped caring about his personal hygiene.
- 12. I knew David Page, Jr. from school. I knew him as "J.R." David was creepy, I didn't like him very much. I remember one time on the bus, David Page

told a black kid that he could kill him and nobody would care because our school flew a rebel flag. David used drugs while we were in school together.
